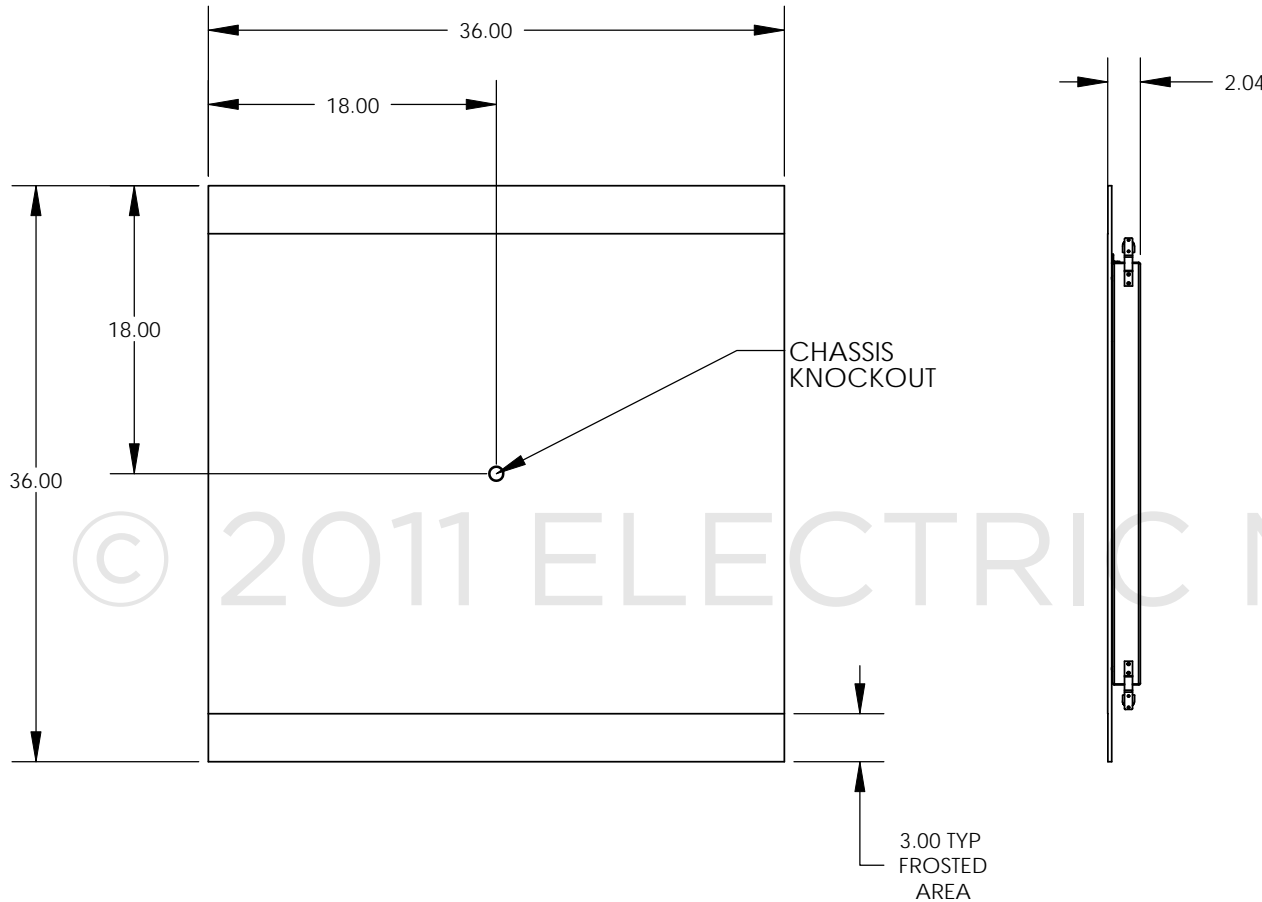

SPECIFICATION:

SPECIFY THE LIGHTING STATION ABOVE THE BATHROOM VANITY. THE TOP OF THE FIXTURE SHOULD BE A MINIMUM OF 6'6" OFF THE FINISHED FLOOR TO ACCOMMODATE THE HEIGHT OF A HOTEL GUEST.

THE MC CABLE IS BROUGHT IN THROUGH THE CHASSIS KNOCKOUT. INSERT GROUND WIRE IN GROUNDED CONNECTOR. INSERT HOT AND NEUTRAL WIRE INTO LUMINAIRE DISCONNECT. NO ELECTRICAL BOX REQUIRED. ELECTRICAL POWER SHOULD BE CONTROLLED BY A LIGHT SWITCH.

FIXTURE SHOULD BE MOUNTED TO A MECHANICALLY SOUND SURFACE SUCH AS WALL STUDS TO SUPPORT ITS WEIGHT. MOUNTING HOLES ARE PROVIDED IN THE CHASSIS.

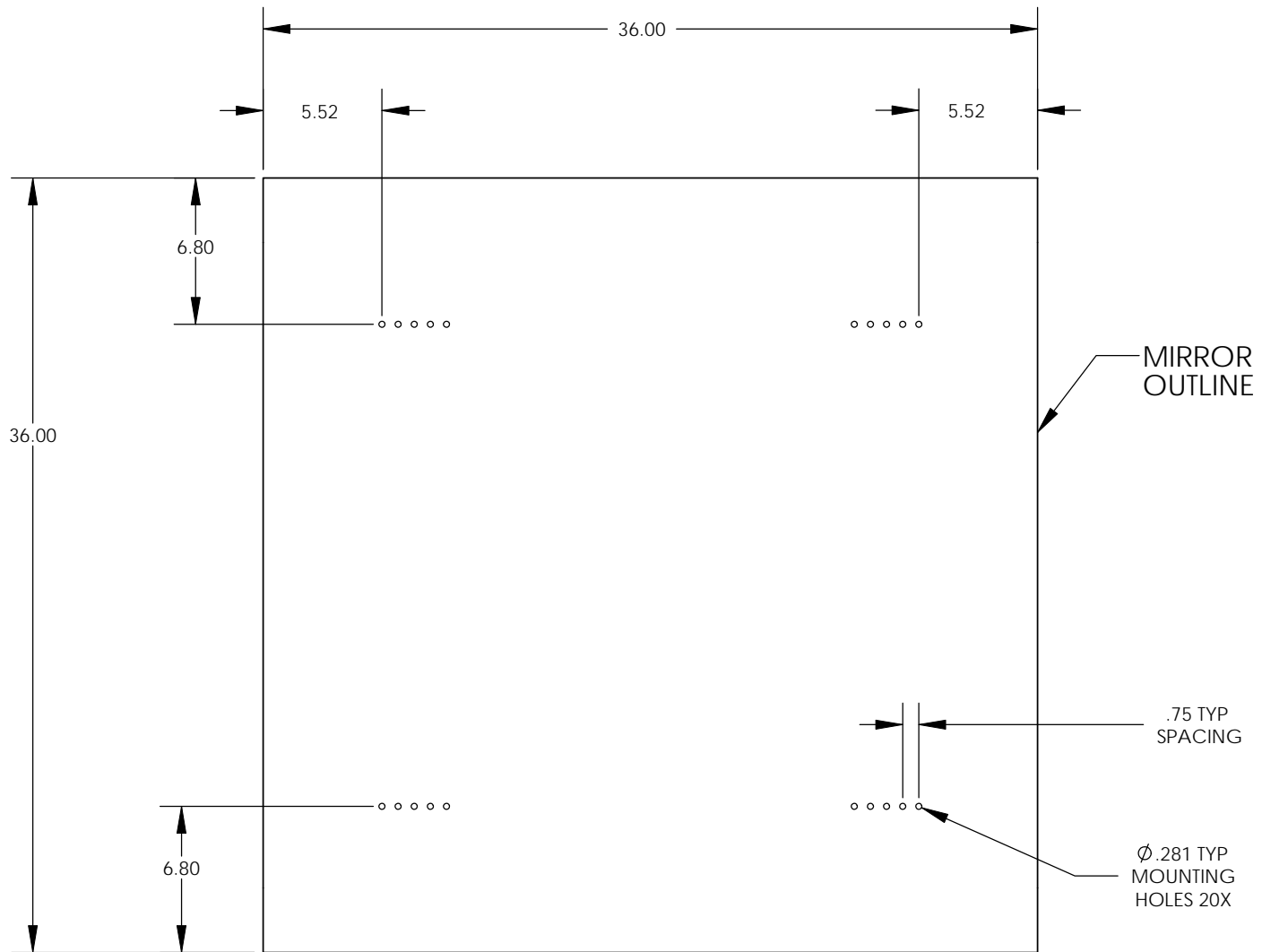
